Pet Adoption Contract and Terms of Adoption

THE ADOPTER MUST THOROUGHLY READ AND AGREE TO ALL TERMS OF ADOPTION

TERMS OF ADOPTION ARE AS FOLLOWS:

The Adopter Agrees to:

- **I agree** to provide nutritious food, adequate shelter, care and medical attention to this animal at all times, as per the Animal Protection Act of Sask., and the provisions of the Cruelty to Animals Section of the Criminal Code of Canada.
- **I agree** to have this animal spayed/neutered at or near six (6) months of age to help prevent the stray and abandoned animal crisis, or within two (2) weeks of adoption, if the animal is already of age (N/A if animal is already sterilized). **Note: PFA does not recommend de-clawing of cats.**
- **I agree** to provide my veterinarian contact information if requested by PFA as concerns this animal, and authorize inquiries of my Veterinarian by PFA if there is any dispute as to sterilization, vaccination or other follow-up medical care having taken place.
- **I agree** to notify PFA immediately at 565-0402 or 522-9770 if: 1) I change my address within 6 months of the adoption date, 2) if the animal is lost or stolen at any time, or 3) becomes ill within 30 days of the adoption date.
- **I agree** to notify PFA immediately at 565-0402 or 522-9770 if I am unable to keep the animal, with the understanding that PFA will assist me in finding a new home, or will place the animal in temporary foster care if a new permanent home is not immediately available.
- **I agree and am contractually obligated as follows:** I will not place this animal elsewhere without the express permission of PFA.
- **I agree** to accept follow-up inquiries on the status of this animal from PFA volunteers, and to respond to them in a timely manner.

Please Note:

- Any additional monies donated above the adoption fee are appreciated and will be applied directly to People for Animals Pet Rescue rescues and sterilizations.
- Adoption fees are not refundable.
- PFA cannot guarantee the health, temperament, or behaviour of the animal.
- PFA does NOT routinely test cats for feline leukemia or HIV/AIDS, but contract will note, if done.

The Foster Parent Agrees to Follow the Instructions for Adoptions as Outlined in the Foster Parent Contract, and:

- **I agree** to prepare two copies of page 2 of this document (the Adoption Contract), COMPLETED IN FULL, and signed by the Adopter. A copy is to be retained by the Adopter, and a copy is to be retained by the Foster Parent to be returned to PFA.
- **I agree** to give the original spay-neuter record to the Adopter in the event that it resides with me.
- **I agree** to collect a non-refundable adoption fee, as advised by the PFA Screening volunteer or Foster Parent Liaison.
- **I agree** to contact new owner to follow-up within 1 week post adoption and record findings on page 2 of this contract.
- **I agree** to mail in the completed contract, adoption fees and any veterinary records I possess, if not picked up by a PFA staff member. Cash is the preferred method of payment for adoptions, but should not be forwarded in the mail. The Foster Parent may retain the cash, and write a personal cheque to cover the cash fee paid by the adopter, or pass the cash fee to a PFA staff member. Contracts and/or cheques can be mailed to:
